Lessee further covenants to indemnify and save harmless Lessor for and against any and all liability arising from injury arising during the term of this lease to person or property occasioned wholly or in part by any act or omission of Lessee or the guests, employees, assigns, or sublessees of Lessee, including but not limited to use of the leased items for a use to which said items are not intended or suited, including unintended uses that may be foreseeable, loss due to intoxication of occupants or guests, uneven or unstable ground, losses beyond Lessor's control or any improper use of any leased item.

The invalidity of any portion of this agreement will not and shall not be deemed to affect the validity of any other provision. In the event that any provision of this agreement is held to be invalid, the parties agree that the remaining provisions shall be deemed to be in full force and effect as if they had been executed by both parties subsequent to the expungement of the invalid provision.
